CAMERAS/VIDEO:

1. No video equipment is allowed in the auditorium.
2. No professional photography is allowed.
3. No soliciting of photo, or video services is allowed on the premises.
4. No camera bags, or equipment are allowed in the auditorium.
5. Spectators who have purchased a ticket are allowed access to the event with one (1) camera only.

CHECK-INS & WEIGH-INS:

Both Figure and Bikini division athlete brief and check-ins will be held at the event hotel Radisson-Westside on Friday, Dec. 3rd at 6:30pm. There will be no check-ins for Figure or Bikini contestants on day of contest. Hotel address is 6161 W. Centinella Ave, Culver City, CA 92030. Check-ins for NPC Men & Women's Bodybuilding will be held at Veteran's Memorial Auditorium, 4117 Overland Ave, Culver City, CA on Saturday, Dec. 4th at 8 am.

ELIGIBILITY:

This competition is open to all NPC registered athletes who meet the following requirements:

1. Possess a current NPC card (unregistered athletes may purchase cards for \$90.00, which is valid thru December 31, 2011). NPC cards available at check-in.
2. Novices who have not won any OVERALL TITLE
3. Men's Masters, men who have reached 40 and 50 years of age by date of show.
4. Women's Masters Figure/Bikini - women who have reached 35, 45 and 50 years of age by date of show. (All competitors must be 18 years or older on the day of the contest. Masters must show proof of age, i.e., driver's license, birth certificate).
5. All Figure competitors must have reached their 18th birthday by the day of the contest.
6. Figure and Bikini cannot 'cross over' between the two divisions. Cross overs are allowed within the divisions.

NOTE: Each contestant may enter more than one division, however a separate entry fee must be paid for each division entered. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.

Please be on time! All Bodybuilding competitors will perform 60 second posing routine at the evening finals.
