- CAMERAS/VIDEO:**
1. No video equipment is allowed in the auditorium.
  2. No professional photography is allowed without prior approval of the contest promoter, or district chairman.
  3. No soliciting of photo, or video services is allowed on the premises without prior approval of the contest promoter.
  4. No camera bags, or equipment are allowed in the auditorium without prior approval of the contest promoter.
  5. Spectators who have purchased a ticket are allowed access to the event with one (1) camera only.

- CHECK-INS & WEIGH-INS:**
- Figure & Bikini division athlete brief and check-ins will be held at the event hotel Radisson-West Side on Friday, at 6:30 pm. There will be no check-ins for Figure or Bikini contestants on day of contest. Check-ins for Men & Women's Bodybuilding and Men's Physique will be held at Veteran's Memorial Auditorium on Saturday at 8 am.
- ELIGIBILITY:**
- This competition is open to all NPC registered athletes who meet the following requirements:
1. Possess a current NPC card (unregistered athletes may purchase cards for \$100.00, which is valid thru Dec. 31, 2012, at the prejudging check-in).
  2. Novices who have not won any OVERALL TITLE.
  3. Men's Masters, men who have reached 40, 50 or 60 years of age by date of show.
  4. Women's Masters - women who have reached 35, 45 or 50 years of age by date of show.
  5. Teenage competitors must not have reached their 20th birthday by the day of the competition. (All competitors (except TEENS) must be 18 years or older on the day of the contest. Masters & Teens must show proof of age, i.e., driver's license, birth certificate).
  6. No cross-overs between figure division and bikini division are allowed. Cross- overs are allowed within each category.
  7. TEEN MEN'S PHYSIQUE competitors are eligible to compete if they are between the ages of 16 and 19 and must not have reached their 20th birthday on or before day of contest. Teens can cross over into unlimited physique division only if they are 18-19 years old. No exceptions.
- NOTE: Each contestant may enter more than one division at a cost of \$90 per division. Athletes may change divisions at the check-in, but changes must be made before the prejudging starts.
- Please be on time! All Bodybuilding competitors will perform 60 second posing routine at the evening finals.
- MUSIC:** CD ONLY (no cassettes). Each CD must contain only one song (music mixing allowed) and must bear the contestant's name. Each contestant is responsible for picking up his/her music at the Evening Show. Lindsay Productions will not accept liability for music left behind. There is no music or posing requirements for Men's and Women's Physique.
- POSING LIMIT:** For Bodybuilders there will be no 60 second free posing round at prejudging. Everyone will perform at the evening finals. Bodybuilders are limited to 60 second posing routine at evening finals.
